APPENDIX

MAILED IDENTIFICATION

You may choose to verify yourself by mailing to us, along with this application, original certified copies of acceptable ID as outlined below.

PRMARY ID DOCUMENTS

Provide ONE of the following only:

- Australian Driver's Licence (including the back if you have changed your address) MUST be current
- Australian Passport (a passport expired within the previous 2 years is acceptable)
- Proof of Age card issued by a State or Territory MUST be current

SECONDARY ID DOCUMENTS - if you do not own any of the above documents

Provide ONE of the following:

- Australian Birth Certificate or birth certificate issued by a foreign government
- Australian Citizenship or citizenship certificate issued by a foreign government
- Pension card issued by Centrelink
- Medicare Card issued by the Australian government

Plus ONE of the following (must contain full name and residential address):

- A utility bill of no more than 3 months' old
- A document issued by a local government body no more than 3 months' old
- A document issued by the Australian Taxation Office no more than 12 months' old (block out TFN no. before supplying)

FOREIGN ID DOCUMENTS

Provide a foreign passport or similar travel document containing a photograph and the signature of the person* OR both of the following:

- Foreign driver's licence that contains your photograph and date of birth*
- National ID card issued by a foreign government containing a photograph and a signature of the person

PLUS a utility bill of no more than 3 months' old or any other statement that confirms your residential address *Any non-English documentation must be accompanied by an English translation prepared by an accredited translator.

Certifying your documents

All copies of ID submitted to us must be certified by an approved certifier. We cannot accept copies of your ID or copies of certified copies (where the certifier's signature is not an original). You can have copies of your ID certified by any one of the following:

In Australia:

- Health professions: Pharmacist, Chiropractor, Dentist, Medical practitioner, Nurse, Optometrist, Physiotherapist,
 Psychologist
- Legal professions: Legal practitioner, Patent attorney, Trade marks attorney
- Court positions: Bailiff, Justice of the Peace, Judge, Magistrate, Registrar, or Deputy Registrar, Clerk, Master of a court, CEO of a Commonwealth court
- Accountant (member of ICA, ASA, NIA or CPA, ATMA, NTAA)
- Member of Chartered Secretaries Australia or Engineers Australia
- Commissioner for Affidavits, or Commissioner for Declarations (dependent on jurisdictions)
- Government representatives (elected): Federal, State or Territory or Local
- Public servants: Federal, State or Territory or Local employed for five years or more.
- Permanent employees of the Australian Health Practitioner Regulation Agency
- Bank officer, building society officer, credit union officer, finance company officer employed for five years or more
- Veterinary surgeon
- Minister of religion, or marriage celebrant
- Australian Defence Force (an officer; or a non-commissioned officer with 5+ years of continuous service; a warrant officer)
- Australasian Institute of Mining and Metallurgy

- Notary public
- Police officer, Sheriff or Sheriff's officer
- Teacher (full-time) at a school or tertiary education institution

Outside Australia:

- Justice of the Peace
- Notary public
- Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the Consular Fees Act 1955)
- Employee of the Commonwealth or the Australian Trade Commission who works outside Australia.
